

此北村靜香作純銀 口打出捶打紋銀壺, 壺身及嘴以一枚銀板捶打成型,無焊接、 鉚釘痕跡,渾然一體,宛若天成,飽滿 優美至極, 壺身光素不加紋飾, 更顯出 線條肌理天然趣味。豆莢形鐵提把配環 形鈕摘巧添意趣,繁簡之間可體會北村 靜香的大師級工藝與審美品格,宜賞宜 用,不可多得。

北村靜香少時拜於傳奇金工師真鍋靜良 門下,學習並發揚「槌打」及「一枚打出」 的絕技,被稱為「一塊造」最後的巨匠, 以「銀壺的北村」之名享譽全日本。

光玉堂是日本知名製壺精品堂號,創號 於江戶時期。此堂口所製鐵壺,以獨特 的設計感而著稱,簡樸素雅又匠心別具, 是低調而精工的堂口。此壺為光玉堂初 代堂主佐藤 提製,壺身以花鳥裝飾,金 銀相間,壺身丸型岩肌,略白。壺咀厚 實圓滑,提梁與壺蓋材質相同。壺摘為 空心丸形,狀如鞠,鈕座紋飾與摘鈕相 同。壺蓋方型,在該堂作品中甚為罕見。

此組茶具外施醬釉,內以青花為飾,繪有山水舟船圖樣, 精緻清麗。此种外醬釉里青花瓷器,將宋代開始流行的醬 色釉與元代盛行的青花瓷相融合, 創製於明初, 明清至民 國時期持續燒造,迎合了海外市場對深色宋瓷與青花圖案 的喜好。醬釉又稱紫金釉,以氧化鐵為星色劑,青花則以 氧化鈷呈色,皆為高溫色釉。這種幽古的醬釉加上淡雅的 青花,在同一瓷器上表現的器物,頗受西方人的喜愛,多 以此為咖啡具和茶具。舊時此種瓷器經荷屬印尼的巴達維 亞運抵歐洲,故被稱作巴達維亞瓷,是外銷瓷器的經典品種。

一組十件青花瓷茶碗,胎質細膩致密,釉質肥潤,青花發色淡和。底有宣德年制款。口沿與圈足飾弦紋繞緣,每只茶碗上繪蘆雁圖,畫法疏簡,筆觸揮灑自如,氣韻生動。蘆雁典故出自漢代揚雄《法言·問明》:治則見,亂則隱。鴻飛冥冥,弋人何慕焉?宋代以來蘆雁小景成為士大夫鍾愛的文人畫題材,象徵隱逸高潔,蘇軾有《惠崇蘆雁》詩:惠崇煙雨蘆雁,坐我瀟湘洞庭。欲買扁舟歸去,故人雲是丹青。此杯一套十隻,可供與友人清談對飲,發林泉之思。

具輪珠為紫砂壺中的名品,為晚清民國時期為外銷日本而設計,當年即風靡東瀛,成為明治時代茶人競相追捧的珍品。日人奧蘭田於紫砂壺名著《茗壺圖錄》中記載具輪珠樸而雅,京阪好事家爭相競求,甚至流傳非獲具輪珠者,難與言茗事。此清代紫泥鋪砂具輪珠一對,紫泥深邃古雅,鋪陳細膩,玲瓏之中蘊無窮韻味,不難想見當年東瀛茶界渴望心醉,一觀此壺,津津流涎的情狀。






